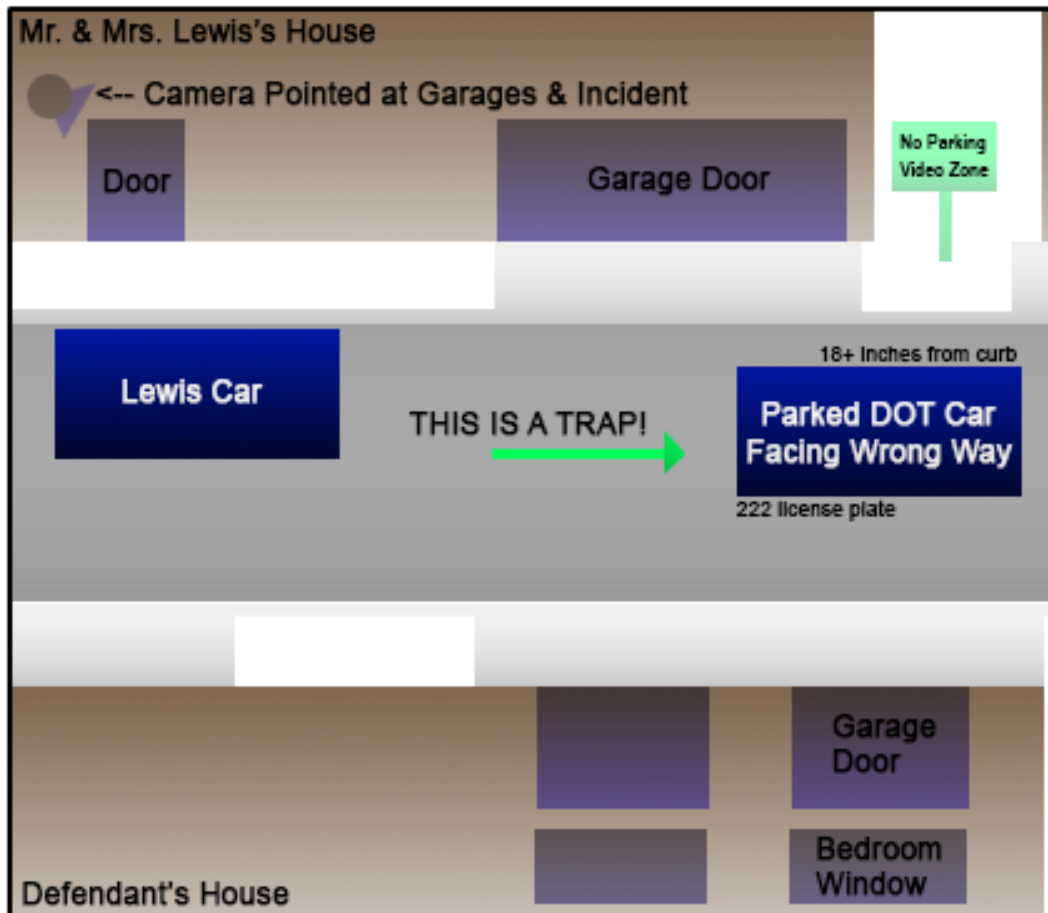

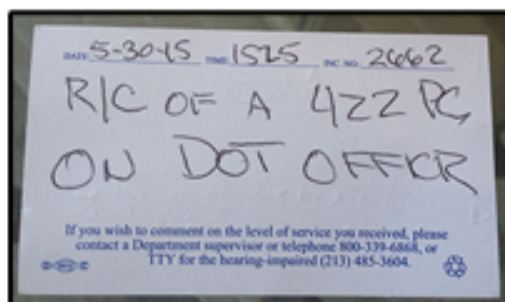


DOT Car Infront Of "No Parking" & Video Surveillance Signs

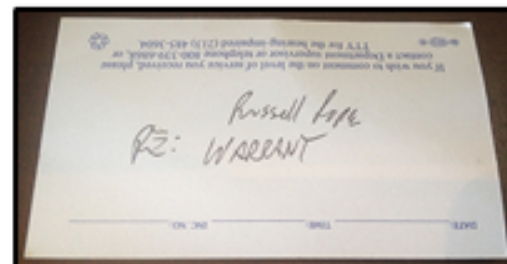

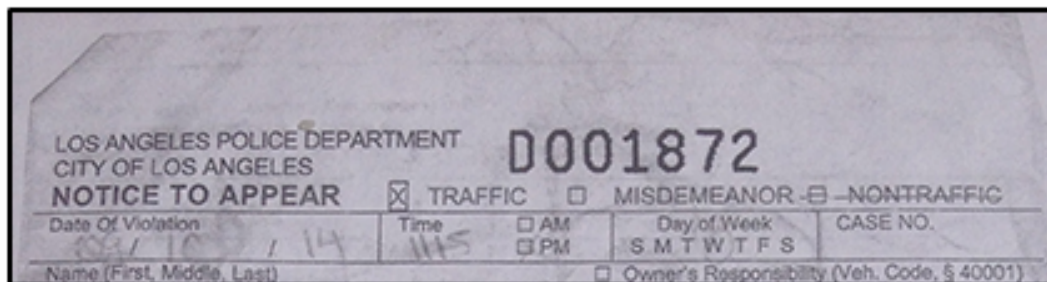

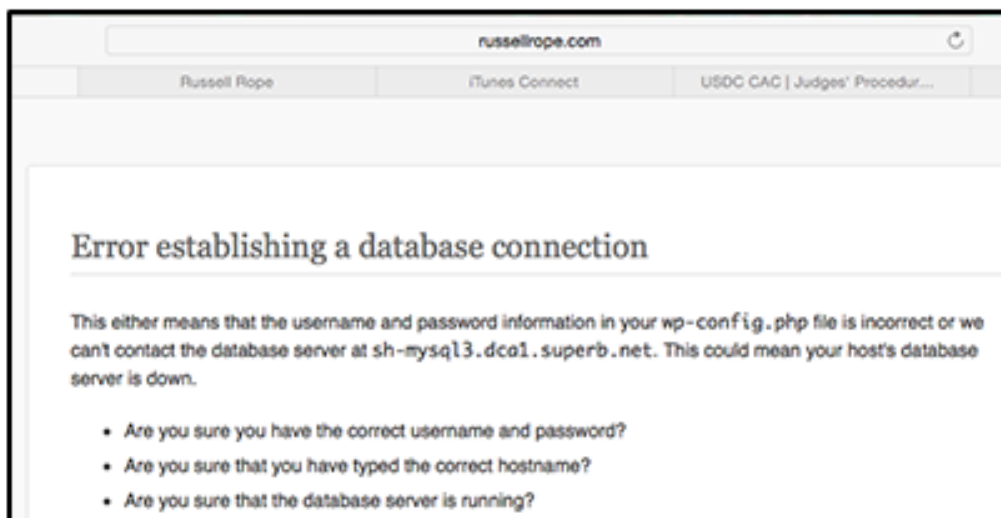

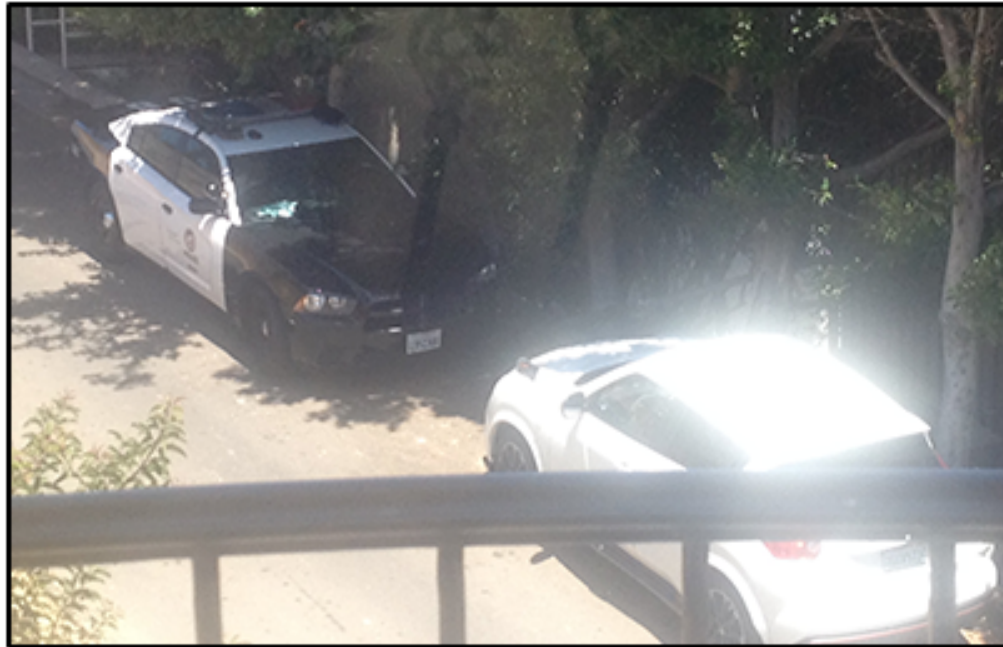

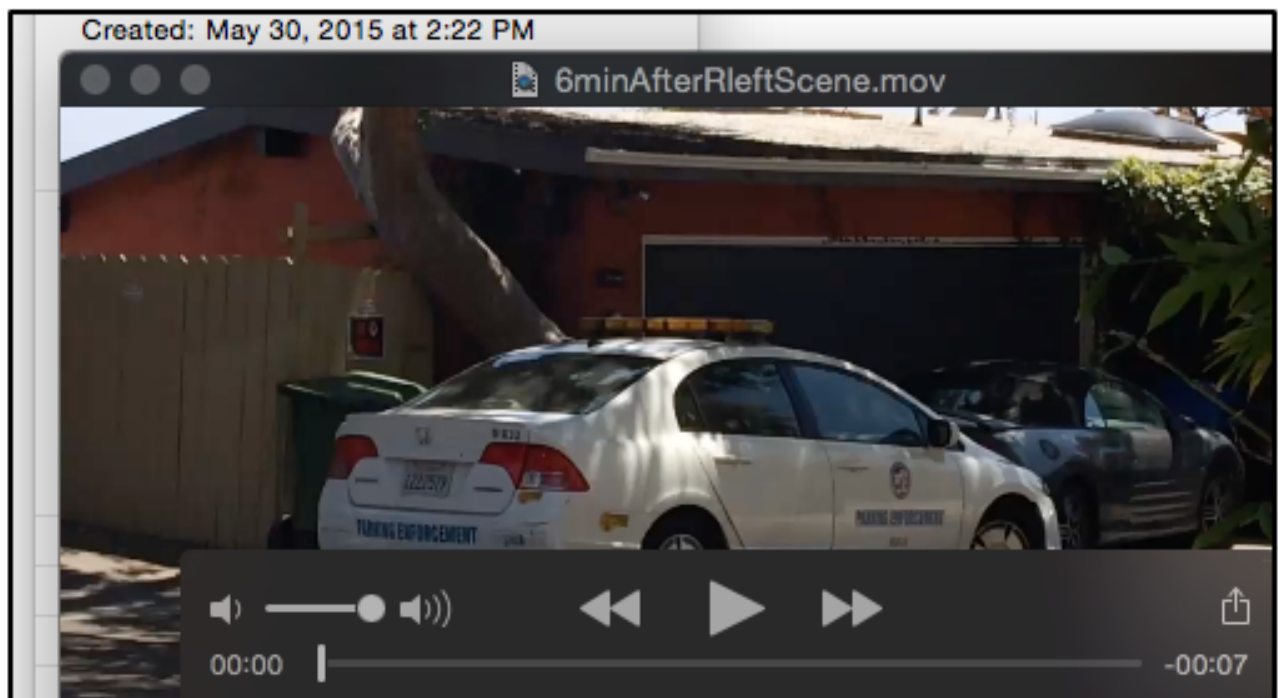
